



These terms and conditions govern The Wedding Gallery Rewards loyalty programme operated by The Wedding Gallery International Limited of 2 Omega Place, London, N1 9DR (Company No. 10589670) (“The Wedding Gallery”) under which cardholders earn The Wedding Gallery Rewards points on certain purchases and supplier bookings in accordance with the terms below (the “Programme”).

### **COLLECTING THE WEDDING GALLERY REWARDS POINTS**

Customers earn The Wedding Gallery Rewards Points on qualifying purchases at The Wedding Gallery and on confirmed bookings with suppliers when referred through The Wedding Gallery. (as defined below in ‘Qualifying In-Store Purchases, Supplier Bookings and Exclusions’)

If a Customer is given a refund or other financial adjustment on any transaction, The Wedding Gallery Rewards Points awarded on the transaction will be adjusted accordingly.

### **QUALIFYING IN STORE PURCHASES, SUPPLIER BOOKINGS AND EXCLUSIONS**

Subject to the exclusion of certain departments and brands, Customers can earn The Wedding Gallery Rewards Points on purchases made at The Wedding Gallery and through confirming supplier bookings when referred through The Wedding Gallery.

Customers can not earn The Wedding Gallery Reward points on:

Crockery Hires, Furniture Hires, Gift Cards and Gift Vouchers, Alterations, Delivery Charges, Appointment Fees, Event Fees and Purchases through The Wedding Shop, Jo Malone, Aqua de Parma, Agent Provocateur, Not on the High Street, and Moët event orders.

Customers can only spend The Wedding Gallery Reward points on:

In store purchases across fashion, jewellery, accessories and food & beverage. Points cannot be redeemed on sale items and specific brands, including The Wedding Shop, Agent Provocateur, Jo Malone and Aqua de Parma. Points cannot be redeemed against any external contracts with wedding suppliers.

### **THE WEDDING GALLERY REWARDS UPDATES AND CHANGES TO THE PROGRAMME**

The Wedding Gallery has the right to terminate the Programme or makes changes to the terms of the Programme at any time. The Wedding Gallery will not be liable for any resulting loss or damage. A Customer will be deemed to have accepted any changes or variations by the continued use of a Rewards Program.

## **GENERAL**

Rewards Points are non-transferrable.

Reward Points are valid for 1 year from date of transaction or the date of the supplier booking confirmation.

The Wedding Gallery shall not be liable for any damage, theft, loss or unauthorised use of any customers Rewards.

If there is any difference between the terms and conditions as set out on The Wedding Gallery.com and other information provided in relation to the Programme, the terms and conditions on The Wedding Gallery.com will prevail.

These terms and conditions do not affect the customers statutory rights.

These terms and conditions are governed by English law and are subject to the exclusive jurisdiction of the courts of England and Wales.
